**Competition judging will be held Saturday, June 25, 2011, at Zentmire Hall, Iowa County Fairgrounds. The day will begin at 10:00 a.m. with individual interviews.**

We will host a noon potluck with the Fair board members and judges. After the potluck, the judges will meet with the candidates for group interviews. The judges will base their decision on personality, attitude, appearance, awareness, leadership and citizenship, contribution to the community, charm and poise.

Another letter will be sent to you prior to the Miss Iowa County contest with more complete details.

Money will be provided making it possible for Miss Iowa County Fair Queen to compete in the Iowa State Fair Queen Pageant held in Des Moines during the State Fair in August.

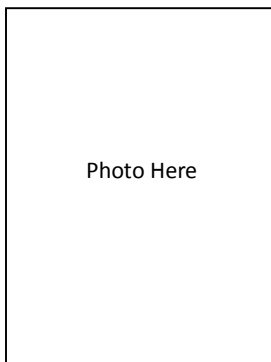
